

SUMMARY ANNUAL REPORT FOR VEEV OPERATIONS LLC HEALTH AND WELFARE PLAN

This is a summary of the annual report of the VEEV OPERATIONS LLC HEALTH AND WELFARE PLAN, a health, life insurance, dental, vision, long-term disability and death benefits plan (Employer Identification Number 35-2605842, Plan Number 501), for the plan year 07/01/2021 through 06/30/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with UNITED HEALTHCARE INSURANCE COMPANY, PRINCIPAL LIFE INSURANCE COMPANY and KAISER FOUNDATION HEALTH PLAN INC to pay certain Health, Dental, Vision, Life insurance, Long-term disability, PPO contract, Indemnity Contract, Prescription drug, HMO contract claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2022 were \$3,017,842.
